I fully understand and acknowledge that (a) dangers exist in my use of paintball equipment and my participation in paintball activities (b) my participation in such activities and/or use of such equipment may result in my injury or illness included but not limited to bodily harm, disease strains, fractures, partial and/or paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability: (c) these risks and dangers may be caused by the negligence of the owners, employees, officials or agents of BPF, the negligence of the participants, the negligence of others, accidents, breaches of contracts, the forces of nature or other causes. These risks may arise from foreseeable or unforeseeable causes, and (d) by my participation in these activities and/or use of equipment I hereby assume all risk and dangers and all responsibilities for any losses and/or damages whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers or employees of BPF or by any other person.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, hold harmless, defend and indemnify BPF and its owners, agents, employees and officers from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of service or otherwise which may arise out of my use of paintball equipment or my participation in paintball activities, I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, employees, agents and officers of BPF.
